The responsibility of a Junior Counselor will be to aid in the assistance of the counselors. Their daily assistance will be needed in setting up arts and craft, setting up and assisting in activities with the children. These are some of the task that they will be responsible for in their role as a Junior Counselor. Junior Counselors must attend training as outlined by the County Programs Coordinator. Junior Counselors are not staff. Therefore, they do not have the right to be present at all informational meetings and they cannot discipline a participant at anytime. They are to allow paid staff to deal with these issues. Junior Counselors are held at a higher standard than participants.

I understand there is no weekly charge for junior counselors. However, parents must be prepared to pay field trip costs throughout the summer. Upon approval into the program, a registration fee of \$65 is due. Each junior counselor is responsible for the \$50.00 fee for The Red Cross Babysitting Course. **A junior counselor can be relieved of duty without any notice.**

As parent/guardian I give Horry County Parks & Recreation Department permission to provide my child(ren) with activities and transportation regarding those activities. I also permit them to transport them to any medical facility necessary. I hereby release Horry County (all departments), Horry County School District, agencies used for transportation, all facilities associated with field trips, Horry Council on Aging, & Horry County Parks & Recreation, their employees, & instructors from all incidents and/or accidents suffered by my child or myself.
